-**Road Report:** A discussion took place to purchase ashes and/or salt independently since there has been complications getting ashes from Monongahela Township. Update from Brian Lake of K2 Engineering that sink hole project at Diamond & Front Street should be ready to advertise in two weeks.

-**Rental: Whipkey Heating** repaired the furnace at 102 Minor Street. Findings were that the drains were clogged. Downspout and gutter will be repaired in the spring at 415 Walnut Street by Tom Bate.
